Service Agreement

- Website Plans are contracted to a minimum of 12 monthly payments.
- After the minimum payments and contract length is completed, you will
 automatically be placed into a 1-month contract, with a period of 30 days'
 notice to cancel. This will happen automatically without notification and
 will be the customer's responsibility, to ensure they cancel if they want to
 after the minimum period has ended.
- Please be aware that any additional extras, features, pages, plugins that are not included within your plan will occur an extra £50 fee for any amendments or additional changes.

Definition of the terminology used in this document

- The terms "Your" or "You" is the end user accessing the website or using our services. "Us" or "We" or "Our" stands for our business CreativeLocker.co.uk.
- The term 'Project' stands for any work CreativeLocker.co.uk undertake or any service provided by us, described on our website based upon the applicable plan.
- The term 'Live Date' describes the date your website will be published.
- The term 'Hosting' describes an essential service required for your website to work online.
- The term 'Domain' describes your websites address, which specifies an available domain name or self-owned domain name, which will be used for the client's website.
- The term 'Open Source' is describing the use of software freely available for anyone to use under the GNU General Public License.
- The term 'Content' describes both the images and text used on a client's website.

- The terms 'Contract', 'Contract Agreement' and 'Terms & Conditions' is all terms used for this Contract Agreement.
- The term 'SEO' stands for 'Search Engine Optimisation' in full.

Background Check

- CreativeLocker.co.uk reserve the right to conduct a background check on your personal profile or/and your business (if a limited/partnership/another type of a company). This will usually be conducted by the 192.com service, but we reserve the right to also conduct this search, using other third-party providers. We hold the right to conduct this without notification to the client.
- Information from the background check might be saved, so we can compare this information to the ones provided by the client's registration form.
- Management reserve the right to ask further questions, request identification or refuse our services, for any reason we deem necessary. This contract can be terminated for any reason if we deem that is necessary, from the results of the background check.

Service Eligibility

If no active subscription is set up, this fee will be added to an invoice for Debit/Credit Card payment.

- No refund of the first monthly payment will be provided, on a result of a cancellation.
- We have the right to charge a £15 fee if a subscription is cancelled, during a contractable term. If you need to change your card details, you must not cancel your subscription and instead update your card details through your account, alternatively get help by emailing info@CreativeLocker.co.uk
- We hold the right to reattempt failed subscription payments automatically
- It is a requirement to have an active subscription set up at all times if you have any pay monthly services with CreativeLocker.co.uk.
- We hold the right to change our payment gateway provider at any time or payment method type, and clients will need to re-setup with the new method.
